





#### APPOINTMENT OF NON-PERMANENT TRUSTEES:

- That the founder President of the Trust in consultation with the other (a) permanent trustees may appoint or nominate any number of nonpermanent trustees with a right to vote and holding office for one year. After the demise of the founder such power will vest with the permanent trustees to appoint and nominate non-permanent trustees.

#### SPECIAL PATRONS, ADVISORS, CONSULTANTS 11. INVITEES:
